

UBER Driver Terms and Conditions

Terms & Conditions of Operating at Rotorua Regional Airport	
Fees	Airport Authorised Drivers entering the Pick-up Area and picking up passengers will be charged the Per Trip Fee by RRA. The Per Trip Fee will be collected by Rasier on behalf of the RRA unless indicated otherwise.
Permitted Use	RRA will permit Airport Authorised Drivers to use the Designated Areas for the uses specified below (collectively, "Permitted Use"). However, Airport Authorised Drivers waiting to accept trip requests at the Airport shall not loiter or tout for business in the Airport roadways (including the Pick-Up Area) and must comply with RRA's requirements (if any) in relation to Designated Areas from time to time.
Holding Area	Any and all Airport Authorised Drivers waiting to accept trip requests at the Airport, shall not loiter in the Airport roadways (including the Pick-Up Area), but instead shall wait in the approved staging area known as the "Holding Area" as shown on Attachment 1.
Pick-up Area	Any and all Airport Authorised Drivers who have accepted a trip request are permitted to enter the Pick-up Area as shown on Attachment 1. The Pick-up Area may only be used to pick-up passengers.
Airport Authorised Driver Requirements	<p>(i) each Airport Authorised Driver will obtain and comply with all necessary consents from all relevant authorities for the Driver to operate their Vehicle using the App;</p> <p>(ii) each Airport Authorised Driver must hold and maintain a valid driver's licence with the appropriate level of endorsement as required by applicable law to operate their Vehicle;</p> <p>(iii) each Airport Authorised Driver must ensure that their Vehicle is in a serviced, roadworthy and undamaged condition. Vehicles must be no more than 10 years old (unless specifically agreed otherwise by RRA). The exterior must not have any obvious damage and the paintwork shall be in good condition without obvious scratches or blemishes. The vehicle must be clean, inside, and out.</p> <p>(iv) each Airport Authorised Driver will comply with any Safety Management System ("SMS") implemented by RRA as a requirement of the Civil Aviation Authority of New Zealand and its health and safety duties. The Driver acknowledges that RRA may amend the terms of its SMS from time to time. In the absence of any SMS, the Driver shall have regard to and adhere at all times to any health and safety and security requirements implemented by RRA from time to time;</p> <p>(v) each Airport Driver must abide by the speed limit within the Airport access road, carpark and ring road.</p>
Drivers Conduct	Drivers must be courteous and well presented. Airport Authorised Drivers must not do anything or omit to do anything:

	<p>(i) which would be reasonably likely to constitute a nuisance, annoyance or danger to any person or to any portion of the Airport or which interferes with the use and enjoyment of the common areas of the Airport by members of the public and other tenants and licensees of RRA;</p> <p>(ii) to contaminate or pollute the Airport; or</p> <p>(iii) to damage or destroy anything on Airport property.</p>
Accurate Information	The information provided by the Owner/Operator shall be complete and accurate. The Owner/Operator must update RRA in a timely manner if any of the information provided changes.
Cancel/Change	<p>RRA may at any time change, alter and expand the Airport, including the terminals, roadways and designated pick-up, drop-off and staging areas. RRA will provide Airport Authorised Drivers with reasonable notice of such changes via Rasier.</p> <p>RRA has made no representations, warranties and/or covenants to Airport Authorised Drivers regarding the design, construction, passenger or automobile traffic, or views of the Airport. Airport Authorised Drivers acknowledge and agree that the Airport may from time to time undergo renovation, construction and other Airport modifications requiring the Designated Areas to be relocated. RRA will provide Airport Authorised Drivers with reasonable notice of relocation. RRA will not be liable for any losses incurred by Airport Authorised Drivers in respect of such relocation.</p>
Failure to Comply	Failure to comply with Airport T&Cs may result in Airport Authorised Drivers becoming an Unauthorised Driver and being unable to offer transportation services at the Airport
Ad hoc rules	Nothing prevents RRA from imposing any other rules, procedures or directions on Drivers as required from time to time in connection with the transportation services offered by the Airport Authorised Drivers at the RRA. RRA will notify Airport Authorised Drivers and Raiser of, and Rasier will take reasonable steps to inform Airport Authorised Drivers regarding, such rules, procedures or directions at the relevant time.
